

Dear Friends,

The last year was one of great triumphs and great challenges for TRU Community Care, as we embarked on new projects, engaged and served our community, and like many others in the industry, worked to adjust to the complexities of a changing healthcare system. We hope that you find helpful information about our organization in the following pages as we share some stories from community members and explain our operations.

In summer 2015, we broke ground on a new building, just a block away from our Trailridge offices in Lafayette. The new campus will house TRU's new senior care program, PACE (Program of All-Inclusive Care for the Elderly), and our Grief Services. The PACE services will allow us to reach seniors 55 and older who are nursing home eligible, but want to remain living independently for as long as possible. In addition, our Grief Services, which have outgrown their current offices in Boulder, will have a permanent home.

Following our 2014 consolidation with Hospice of Northern Colorado, we've continued to integrate our operations, including our name – Hospice of Northern Colorado is now TRU Hospice of Northern Colorado and has adopted a new logo. We know this partnership will help us create a stronger, lasting nonprofit hospice for the future.

In the meantime, we've been working hard to fulfill our mission of providing compassionate, quality end-of-life care to all who need it, regardless of ability to pay. Additionally, we remain committed to providing grief services and counseling to anyone in the community who seeks our help. Because of these commitments, there is a gap between reimbursement and costs, and in 2015, we relied on community investment and our loyal supporters to meet our financial goals.

We thank you for being part of another exciting year at TRU. We hope we can count on your valued support so that we can continue to bring our important services to everyone who needs us.

They're more than numbers to us:

During 2015, we served 1,411 patients and families who were living with a terminal illness or with an advanced disease, offering our expert medical, emotional, and spiritual care and support.

- 1,153 received hospice only
- 258 received palliative home health and social work counseling
- 422 stayed at the TRU Hospice Care Center at some point during their treatment

Additionally, 112 patients requested a palliative care consultation for guidance on symptom management

62% of patients received care for 30 days or fewer – many families told us they wish they had contacted us sooner in the disease trajectory

\$67,495 provided in indigent services to people who did not have the means to pay for care.

GRIEF SUPPORT

2,219 TRU Hospice family members received up to 13 months of individual or family grief counseling

659 adults participated in our TRU Hospice support groups, offered free of charge to anyone in the community

186 children and teens participated in our Healing Circles groups, engaging in activities such as glass-blowing, arts and crafts and healing with horses.

TRUIY DEVOTED VOLUNTEERS

In 2015, 385 volunteers dedicated 24,958 hours to care for patients and their families, walked alongside those who are grieving, assisted with administrative tasks, and staffed the TRU Hospice Thrift Shop. During 2015, 50% of patients were touched by volunteers. This service is valued at \$640,946 and equal to 12 full-time positions.

Some of the unique services provided by volunteers included 175 Pet Companion services, 200 hours of Veteran-to-Veteran companionship and 250 hours of Comfort Touch, a specially developed acupressure therapy that serves as a massage alternative for frail patients.

Volunteers have been particularly invaluable to the success of the TRU Hospice Thrift Shop, w here 105 volunteers logged hours in 2015. These efforts contributed to a 14 percent growth in revenue over 2014.






WHERE OUR CARE IS PROVIDED



Over the years, as our community's needs have grown, we have responded with expanded programs and a growing service area.

PEOPLE WE CARE FOR



CASE FOR SUPPORT

During 2016, we project a funding gap of nearly \$800,000 on patient care and family services. Further, many people who seek our help lack insurance or other means of reimbursement for our services. Nevertheless, we provide the same level of care to everyone, regardless of ability to pay.

COMMUNITY EDUCATION

879 children, teens and adults participated in educational community presentations at schools, faith communities, businesses, nursing facilities, and hospitals.

NEW IN 2015: A NEW BUILDING

In 2015, we broke ground on a new 22,582 square-foot building near our exsiting Lafayette offices that will house our Grief Services and the new TRU PACE program (Program of All-Inclusive Care for the Elderly). We also launched our capital campaign to raise \$6 million for the building. By the end of 2015, we were almost halfway toward that goal. Construction is slated to be finished in spring of 2016.

NEW IN 2015: REBRANDING

In summer 2014, Hospice of Northern Colorado (HNC) consolidated with TRU Community Care, and 2015 brought a further integration of the brands. HNC has taken on the new name, TRU Hospice of Northern Colorado, and has a new logo to reflect our merged operations.

A TRU LEGACY



2015 TOTAL EXPENSES - \$13,655,057




