Founded as Boulder Hospice in 1976, TRU is a Colorado-licensed, Medicare and Medicaid-certified, nonprofit health care organization serving the greater Boulder, Broomfield, Adams, Jefferson, and Weld Counties. With a focus on providing a continuum of care for members of our community living with advanced illness and loss, TRU's programs include TRU PACE (Program of All-Inclusive Care for the Elderly), hospice home care, inpatient hospice care, palliative care, grief services, the TRU Hospice Thrift Shop, a robust volunteer program, a partnership with our sister hospice in Tanzania, and community education and outreach. Additionally, we have TRU Hospice of Northern Colorado, our legacy hospice program serving all of Weld and parts of Larimer County.
